A Message from the Board President and Executive Director

FISCAL YEAR 2023 was one of unprecedented growth for the Counseling Center of the North Shore. Our client base grew by 19%, and our clinical staff held 30% more therapy sessions than during the prior year.

The growth that we are experiencing reflects the increasing incidence of mental illness and the vital need for accessible mental health services.

To meet the need for care in the community, we continue to add therapists to our clinical staff. We have also grown our internship program, and this spring we will launch a fellowship program for recent master's program graduates.

We are also providing more community presentations on mental health topics and workshops for mental health professionals. Examples of CCNS educational programs include a presentation for parents titled "Parenting in the Age of TikTok" and a workshop for professional caregivers on "Compassion Fatigue: Signs, Symptoms, and How to Cope."

The Counseling Center of the North Shore's primary reason for being is to provide quality mental healthcare to those who otherwise would not have access to treatment. During FY 2023, we subsidized over \$330,000 in care for our clients. We are grateful to the individuals, foundations, and organizations that support CCNS and make this possible.

We look forward to the year ahead with optimism, motivated by the clients we care for and the mission we serve.

- Community Education


ACCESS TO CARE

- **CCNS Sliding Fee Scale**: For those without health insurance or with high deductible amounts that make weekly therapy inaccessible, we offer a sliding fee scale. Fees start as low as \$5.00 per session and are based on annual household income and the number of dependents in the household.
- We offer clients the option of in-person or telehealth therapy sessions
- We see clients seven days a week and offer daytime and evening appointments
- We offer Spanish-language therapy


